

## **London Landmarks Half Marathon 2027 Terms and Conditions**

### **1. Registration and Sponsorship**

- a) I agree to pay a non-refundable registration fee of £50 to Northern Ireland Chest Heart and Stroke (NICHS) to secure my place in the London Landmarks Half Marathon 2027 and that this registration fee will be in addition to the fundraising amount of £500. A percentage of this income will cover the costs associated with your participation in this event and all additional funds raised will go directly towards the work of the NICHS.
- b) I agree to raise 75% of the minimum sponsorship target (£375) by the 31st January 2027 or I will not be added to the event console to finalise my entry. This is so NICHS does not lose money invested in the event and used to support your place as we aren't able to carry places over the next year.
- c) I understand that I must ensure that my sponsors are aware that part of my minimum sponsorship will cover my challenge costs. Some participants choose to pay their race entry costs themselves, so they can tell their sponsors that all their money is going to the NICHS and ensuring that, in appropriate cases, we can recover gift aid.
- d) I understand that I must be at least 17 years old on the date of the event to enter.
- e) I agree to represent and raise money exclusively for the NICHS in this event.
- f) I understand that places are not given on a first come first serve basis of when applications are received by the Events Team, and that each application will be reviewed individually. Applicants will be informed via email or telephone if they have secured a place in the event.

### **2. Health and Safety**

- a) I understand that all participants take part in the event at their own risk and agree that, as far as they are aware, are suitably fit and physically able to compete in the event.

Participants who have any doubt about their health or have a medical condition that could be affected by exercise, must obtain their doctor's approval before participating in any event. I understand that the participant is solely responsible for acting on doctor's advice and NICHS shall not be held responsible for any injury or illness that may be caused as a result of the event.

- b) I understand that each participant is responsible for their own actions whilst attending and/or participating in the event. NICHS accepts no responsibility for the actions of the participant nor the consequences of such actions. This continues to the participant's personal belongings, they are brought and stored at their own risk and

NICHHS accepts no responsibility for any items that are damaged, lost or stolen at the event.

c) No illegal substance, performance enhancing substances or intoxicants of any kind are permitted to be brought to the any of the NICHHS events or used by participants prior or during the event. NICHHS reserve the right to refuse attendance at or participation in the event to anyone who has consumed and/or have in their possession any illegal substance, performance enhancing substances or intoxicants of any kind.

d) The swapping or sale of race numbers is strictly prohibited for reasons of safety and primarily for identification by medical staff.

### 3. Images and footage

a) I hereby agree that images or footage taken of me on at the event may be used by NICHHS in future promotional material including our websites, social media and charity magazines and reports, unless stated otherwise. ### 4. Cancellations and Withdrawals

a) Except in exceptional circumstances as determined by NICHHS, I understand that all Registration Fees are non-refundable and may not be deferred towards a future Event. Participants who wish to withdraw from the event should inform NICHHS in writing and all sponsorship forms and money collected needs to be sent directly to NICHHS, and sponsors must be notified. All sponsorship monies will be retained by NICHHS unless sponsors request in writing that NICHHS return it to them within one month of the cancellation (not applicable for online donations).

b) I agree that through signing up to this event I am representing NICHHS and abide to the charities values. NICHHS reserve the right to reject at any time any applicants/participants that are poorly representing the charities values or who are believed to be fraudulent. NICHHS will not be liable in any way to costs associated with the event that may be lost due to the rejection.

c) In the event of a cancellation from the event organisers, NICHHS is not liable for any costs incurred by the individual. This includes, but is not limited to, clothing, equipment, travel (domestic and international) or accommodation.

d) If the event is postponed and the individual is unable to attend, the registration fee will not be refunded. Fundraising would not normally be refunded. But if requested by supporters, this will be reviewed by NICHHS on a case by case basis and upon written request of the payee
